Registration & Payment Policies

Each session will be an 18 week period as follows:

Session I from September 12th, 2011 to January 26th, 2012

Session II from February 6th, 2012 to June 14th, 2012

Registration for Session II will take place the first week of February 2012

The Entire Session ***must be*** paid for at the time of Registration using one of the following

OPTIONS:

- 1 - Cheque for the entire session (dated Feb 1st, 2012)
- 2 – Cheques for the entire session (Feb 1st, 2012 & April 1st, 2012)

All cheques are Payable to “Ann Milne School of Dance”

AVOIDABLE ADDITIONAL CHARGES

- Failure to provide the total number of Cheques required for the option of your choosing, at the time of registration *will result* in a \$ 25.00 Administration Fee being charged to you.
- A \$ 25.00 Administration Fee *will be levied* for NSF Cheques. The Dance School must be reimbursed, including \$25.00 NSF Fee, before the student may continue with classes.
- Absolutely no refunds will be provided for any session unless a doctor’s note is submitted indicating an inability to continue in the program.

Dance School Policies

- 1) *All* students **must** attend lessons, shows and the recital wearing Proper Dance Attire (See Dress Code). Dancers will not be permitted into class, or invited to perform otherwise.
- 2) **No** gum, candy or other food permitted in class.
- 3) *Absence* on a continual basis obstructs progress. Please telephone prior to any absence at (519) 371- 0341. Missed classes **are not** made up at a later date and are **non-refundable**.
- 4) **Be** punctual!! Lateness interrupts precious class time.
- 5) **Arrive** in time to dress and warm-up **prior** to scheduled class time.
- 6) **Show respect** for yourself, for others and for those in authority. Treat one another fairly with dignity, honesty and integrity.
- 7) **Parents\Guardians** who are dropping off children and returning to pick them up, **MUST pick them up inside the building** at the completion of class.
- 8) **Parents\Guardians are not** allowed in the studio during classes, as it disrupts the class and the dancer's progress. You are requested to advise the Teacher, prior to a class commencing, if your child has to leave early and the time of required departure. Parent observation classes will be scheduled throughout the year.
- 9) *If* dance classes are **cancelled due to weather**, a message will be posted at (519) 371-0341 by 2:00 pm and all radio stations will be advised.
- 10) *Dancers will not* be permitted to alternate class times or days from week to week.
- 11) **Highland Dancers** wishing to compete **must be** registered for two classes a week.
- 12) **Parents\Guardians**, who need to speak with their child's Teacher, may do so by leaving a message at the studio. Please **do not** interrupt **ANY** class. Someone will get back to you ASAP.
- 13) All questions concerning a Dancer's ability to compete, take exams, class placement or costuming **are to be** directed to Ann Milne.
- 14) When class is over, remove clothing, shoes and other personal belongings from the studio.
- 15) Water bottles and other recyclables are to be deposited in the blue box. Other waste **must be** placed in trashcans provided. **Food and drinks are allowed in the waiting room and kitchen area only!** You are responsible for ensuring leftovers are properly discarded or taken home with you.
